2021 MADCAD SUBSCRIPTION APPLICATION

Form Instructions - Please Read: NMCOA continues its annual subscription with MADCAD and providing member access to an online library of code referenced standards. Access to these standards is required according to the State of Michigan Bureau of Construction Codes. MADCAD provides a low cost per year alternative to the standards referenced in the codes. For more information on this web based library access and its benefits, see the NMCOA website – www.nmcoa.org. and click on the MADCAD tab.

Subscribers to the NMCOA Subscription must be NMCOA Members: If a member of your staff is not a NMCOA member, please visit the NMCOA website to obtain a membership application for submittal with your MADCAD subscription application. There has not been an increase in the cost of the 2021 subscription. However there is an increase in cost per participating jurisdiction based on the NMCOA last year's reduction in overall subscribers. Even with this increased NMCOA MADCAD subscription fee, the cost for 2021 is far less than building and maintaining the provided referenced standards at the local level. The NMCOA/MADCAD 2021 subscription rate is **\$400.00** per jurisdiction. This cost is based on the total cost to NMCOA divided by the 48 participating member jurisdictions in 2020. Payment provides access to the MADCAD Referenced Standards Library for the year 2021 subscription. Each participating jurisdiction's user is provided with a password for MADCAD access. Those new to this program will receive an email directly from MADCAD with your assigned password. The user's email serves as the "User Name". For those renewing a current subscription, the user names and passwords previously issued remain the same for the users in your jurisdiction. If excess funds are available after all subscriptions are received, meaning additional jurisdictions participate, NMCOA will look at using those funds to add additional months to the 2021 subscription period of 12 months. This will move the subscription expiration out from March to another month further into the year (to be determined once all funds have been received). Again, this will require additional participation to fund an extension beyond the current 12 month subscription currently being renewed.

MADCAD requires that Inspectors covering more than one jurisdiction submit an application for each jurisdiction: This form is required to be completed with all requested information applicable to your jurisdiction entered and submitted along with payment. Only complete applications will be entered into the 2021 NMCOA subscription to MADCAD. Incomplete applications will be returned to the subscriber for completion and resubmittal. Complete User Information for each user is required. Space is available for up to 14 users from your jurisdiction. This document is created as an interactive PDF Form. You can save or open the form online, complete all of the requested information, then print the form for submittal. By doing so, your form will be legible and easily read for processing into the NMCOA records.

If a member of your staff is not already a NMCOA member, complete and submit an NMCOA Membership Application and Fee (\$100.00) with your MADCAD form. Payment must be submitted with the completed form(s). Deadline for submittal and MADCAD participation is March 6, 2021.
