NMCOA has signed on with MADCAD to provide member access to an online library of code referenced standards. Access to these standards is required according to the State of Michigan Bureau of Construction Codes. Subscribers to the NMCOA Subscription must have an NMCOA Member in their jurisdiction. The NMCOA/MADCAD Annual subscription rate of \$450.00 per jurisdiction is based on an overall access cost to NMCOA, with a minimum of 45 participating jurisdictions. Payment provides Annual access to the MADCAD Referenced Standards Library. Each participating jurisdiction will be contacted by MADCAD with login details for each user for MADCAD access. The user's email serves as the "User Name". MADCAD will provide each user with a password for access. **MADCAD requires that Inspectors covering more than one jurisdiction submit an application for each jurisdiction.** This form is required to be completed and submitted along with payment in order for your jurisdiction to participate in the NMCOA subscription to MADCAD. This form is created as an interactive PDF Form. Please complete User information for each user. Space is available for up to 15 users. You can save or open the form online, complete all of the requested information, then print the form for submittal. By doing so, your form will be legible and easily read. Payment must be submitted with the completed form. Renewal forms are requested to be returned no later than June 1, 2024 to avoid interruption of the current access. New users will receive login information after the renewal date.
